Applicable business and sales tax licenses and Certification of Workers Compensation shall be maintained by licensed contractor as required by governing law.

### A-2 SIGN COMPANY

Any Company *not required* by law to maintain a State of Arizona Contractors License in order to engage in the company's principal business related to the on-premise sign industry. Applicable business and sales tax licenses and Certification of Workers Compensation shall be maintained by the company as required by governing law.
